The bidder shall only submit physically their original bid security (ies)/ Additional security (ies) and tender form fee (in the shape of call deposit receipt made in favor of Director General, PDA to the office of undersigned through registered post/ courier before last date and time for bid submission.
4. Received bids shall be opened and evaluated (downloaded from EPADS) on the date and time of opening mentioned above in the office of chairman procurement committee in the presence of bidders and their representatives who opt to be present.
5. The bidders should submit their 2% bid security and additional bid security (if any) as per KPPRA rules and notification No. SRO (14) Vol: 1-24/2021-22/6058-71 dated: 10/05/2022.
6. Clarification/queries, if any, shall be asked/ communicated through EPADS or can be obtained from the office of undersigned during office hours.
