Peshawar Development Authority (PDA), invites sealed bids through EPADS, from the eligible contractors / firms in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 on "Single Stage Two envelope system" under Rule 14(2)(b), on percentage above/ below on BOQ/ Engineer cost estimate (MRS-2025) for the following works. The bidder shall be registered with: (i) e-Pak Acquisition and Disposal System (EPADS) (ii) Pakistan Engineering Council (PEC) for the year 2025-2026 (iii) Khyber Pakhtunkhwa Revenue Authority (KPRA) (active) (iv) Federal Board of Revenue (FBR) (NTN active)(v) Enlisted with PDA/Provincial Enlistment committee KP for the current year and having sufficient experience in the field of work given below:

TERMS & CONDITIONS

- The bidders are advised to read and understand the criteria provided in the BSD's uploaded on EPADS separately for each work.
- The eligible constructors / firms / contractors can obtain sample tender form, Bid Solicitation Documents of each work including Evaluation Criteria / Bidding or Contract Data / BOQs from the official website of EPADS <https://www.eprocure.gov.pk/>.

- Pre-bid meeting will be held on 10/07/2026 at 1400 Hours, in PDA Conference Room under the chairmanship of Chief Engineer, PDA.
4. The bidders shall submit / upload their Technical and Financial bids [by file uploading] through EPADS before last date and time for submission of bids.
 5. The contractor / firm / constructor must upload all mandatory documents like PDA / Provincial Enlistment / renewal, valid PEC Registration, NTN (Active), KPRA (Active), Affidavit of never been blacklisting / litigation status by the Government / Semi-Government or any Autonomous body, etc. on EPADS as per the required criteria.
 6. The bidders shall upload through E-PADS their Financial proposal and submit physically, their original bid security / additional security (if any) in sealed envelope, (in the shape of bank guarantee issued by a scheduled bank in Pakistan/ CDR made in favor of the Director General, PDA) to the office of the respective Deputy Director as mentioned in the BSDs, through registered post / courier before last date and time for bid submission. By hand submission will not be accepted.
 7. The bidders shall submit their 2% bid security and additional bid security (if any) as per KPPRA, rules and KPPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
 8. The received technical bid(s) shall be opened (downloaded from EPADS) in the office of the Chairman procurement committee on the date and time mentioned above, in the presence of bidders or their representatives who opt to be present.
 9. Technical bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents of each corresponding package based on the documents to be provided in the Bidding document meant for submission of Technical Proposals.
 10. The "Financial Bids / Proposals" of only technically responsive and qualified bidders will be opened in the presence of bidders / their representative (who may like to attend) on the date & time to be notified later on. Whereas, the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractor / firm.
 11. In case if Bids / Proposals are not opened on the above-mentioned date due to unforeseen reasons, these shall be opened on the next working day at the same place & time.
 12. Bids only up to two decimal digits (0.00) will be considered for evaluation. If any document submitted along with bid documents found false/fake/bogus, the registration of the contractor / firm shall stand cancelled / blacklisted from PDA.
 13. The content of the bids, uploaded by the bidder on EPADS, shall be readable. Incomplete / disfiguring / overwriting / by hand / conditional shall be considered non-responsive.
 14. Clarifications / queries, if any, shall be asked / communicated through EPADS or from the office of the respective Deputy Director within the office hours before last date and time for submission of bid.
 15. All the Government taxes (Federal, Provincial & any other) will be deducted as per prevailing Government policy.
 16. Submission of the bid by the contractor / firm implies that they are fully conversant with the site, scope of work and terms and conditions laid down in the tender / bid document.
 17. Any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2025 / prevailing market rates for NSI with the approval of the competent authority.
 18. If the Bid becomes tie, it will be decided through open toss.
 19. The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring entity shall upon request communicate to any contractor or firm who submitted a bid or proposal, the grounds for rejection of all bids or proposals as per KPPRA Rule 47.
 20. All other terms and conditions shall remain intact as per guidelines and rules framed by Provincial Government.
