NOTICE INVITING TENDER THROUGH EPADS

Peshawar Development Authority (PDA), Government of Khyber Pakhtunkhwa, invites bids through EPADS, from the eligible Bidders in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 (amended from time to time) on single stage two envelopes procedure. The bidder shall be have or registered with (i) e-Pak Acquisition and Disposal System (EPADS) / Khyber Pakhtunkhwa Public Procurement Regulatory Authority (ii) Valid Pakistan Engineering Council License for the year 2025-26 (in required category having required codes as mentioned in the bid solicitation documents) (iii) Valid Registration of Khyber Pakhtunkhwa Revenue Authority (KPRA) (status shall be active) (iv) Valid Registration of Federal Board of Revenue (FBR) (NTN status shall be active), (v) Valid Registration with PDA/Provincial Enlistment Committee, Khyber Pakhtunkhwa. Other criteria are mentioned in the bid solicitation document having sufficient experience in the field of works given below, on percentage above/below on the BOQ/Engineer cost estimate for the following works:-

Terms and Conditions

1. Tender form, Bid Solicitation Documents (BSD) / Bidding or Contract Data / Bill of Quantity (BOQ) can be downloaded from the official website of EPADS (kp.eprocure.gov.pk), official website of Khyber Pakhtunkhwa PPRA/PDA.
2. The bidder shall submit/upload the technical and financial bids [by file uploading] through EPADS before last date and time for submission of bid.
3. The bidder shall only submit, physically, their original bid security(ies)/additional security(ies), tender form fees (in the shape of call deposit receipt made in favour of Director General, PDA in the office of the undersigned through registered post/courier before last date and time for bid submission.
4. The received bid(s) shall be opened (downloaded from EPADS) on/after the date and time for opening of bids in the presence of bidders or their representatives who opt to be present.
5. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
6. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable.
7. The date and time for opening of financial bid shall be announced after evaluation of technical bids.
8. Bids will be opened in the office of the Head of Procurement Wing PDA alongwith Members in the presence of contractor/their representatives who choose to attend on the day and time mentioned above. In case, if Bids / Proposals are not opened on the above mentioned date due to unforeseen reasons these shall be opened on the next working day at the same place & time.

9. The bidders shall submit their bid security as per KP-PPRA Notification No. SRO (14)/Vol: 1-24/2021- 22/6058-71 dated Peshawar, 10/05/2022.
10. Clarifications/queries, if any, shall be asked/communicated through EPADS.
11. Incomplete / conditional bids with unattested cutting / overwriting / disfiguring shall be considered as “non- responsive”.
12. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
